**PROCEEDINGS:**

In the Proceedings first read above, among other things, orders were issued allowing 31% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.01.2022.

**2.** In the Government Order second read above, orders have been issued revising the rate of Dearness Allowance from **31% to 34%**, payable to the Pensioners/Family Pensioners of the Government with effect from **1<sup>st</sup> July, 2022**. It has been decided to extend the same benefit to the Pensioners/Family Pensioners of TANGEDCO.

**3.** Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of TANGEDCO, be paid Dearness Allowance with effect from **1<sup>st</sup> July 2022** at the following rates:-

<b>Date from which payable</b>	<b>Revised rate of Dearness Allowance (per month)</b>
<b>1<sup>st</sup> July, 2022</b>	<b>34% of Basic Pension/Family Pension.</b>

**4.** The increased rate of Dearness Allowance from 31% to 34%, ordered in para-2 above, shall be paid to the Pensioners/Family Pensioners along with the pension/family pension from the month of November 2022.

**5.** Consequent on increase in the rate of Dearness Allowance from 31% to 34%, the arrears for the period from 01.07.2022 to 31.10.2022 (i.e. from July to October) as ordered in para-2 above, shall be paid to the Pensioners/Family Pensioners on **05.11.2022**.

**6.** The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

**7.** In the case of divisible Family Pension, the Dearness Allowance shall also be paid proportionately.


