#### **PROCEEDINGS**:

In the proceedings first read above, among other things, orders were issued to enhance the maximum ceiling limit from Rs.9200/- to Rs.11,284/- per month at the existing term of Rs.12/- per page for Typing (Original) for data entry (typing) works.

2) Some of the Contractors/ Typewriting Institute executing the work at Headquarters and Distribution Circles have represented to enhance the ceiling limit amount for typing works from Rs.11,284/- considering the rates enhanced by the District Collector, Chennai in his proceedings third read above.

3) The request of the contractors has been examined in detail in the light of the rates fixed for daily wages by the District Collector and it has been decided to enhance the existing wage of Rs.12/- per page for Typing (Oringinal) with a ceiling

limit of Rs.11,284/- to Rs.15/- per page for Typing (Original) with a ceiling limit of Rs.14,580/- per month. Accordingly it is hereby ordered that the rate at existing wage of Rs.12/- per page for Typing (Original) with a ceiling limit of Rs.11,284/- per month for Computer Operator/ Data Entry Operator be enhanced to Rs.15/- per page for Typing (Original) with a ceiling limit of Rs.14,580/- (Rupees Fourteen Thousand Five Hundred Eighty only) per month. In addition to the above, the EPF, ESI employer contribution and GST will be extra as applicable.

4) The other conditions stipulated in the proceedings first read above should be strictly followed without any deviation.
