### **PROCEEDINGS:**

In TNEB Service Regulation, the Regulations 91 (3) (a) and 91 (3) (b) read as follows:-

" 91 (3) (a) Any person appointed by direct recruitment shall possess an adequate knowledge of the official Language of the State, namely, Tamil.

Provided that a person, being otherwise qualified for appointment to the post to which recruitment is to be made, may apply for recruitment to the post, despite the fact that, at the time of such application, he does not possess an adequate knowledge of Tamil ".

(b) "Every such candidate as is referred in the proviso to clause (a) shall, if selected and appointed on or after 10<sup>th</sup> may 1996 pass the Second Class Language Test in Tamil conducted by the Tamil Nadu Public Service Commission or

pass the language test in Tamil referred to in Clause C (i) of this Sub-Regulation conducted by the appointing authority or pass the oral test in Tamil referred to in Clause C (ii) of this Sub-Regulation conducted by the appointing authority, as the case may be, within a period of two years from the date of his appointment. If he fails to pass the said language test within the said period of two years, he shall be discharged from service."

Clause (c) (i) : - A language test of the standard for VIII standard, shall be prescribed for those whose educational qualifications is VIII Standard and above but below Secondary School Leaving Certificate and for those who do not possess an adequate knowledge of the official language of the State of Tamil Nadu as specified below :-

(ii) An oral test of the Standard for IV Standard shall be prescribed for those whose educational qualification is below VIII Standard and for those who do not possess an adequate knowledge of Tamil to find out whether a person is able to converse freely and fluently in Tamil.

2. As per the above said regulations, the following Assistant Engineers/Electrical/Mechanical and Civil, who have not possessed the adequate knowledge of the official language of the State namely Tamil, should pass the Tamil

Language test within a period of 2 years from the date of appointment. But they have failed to do so. However, they have passed Tamil Language Test after the stipulated period of two years due to COVID 19 Pandemic. Therefore, they have requested permission for continuance in service of Board.

4. The representation of the individuals mentioned at paras 2 and 3 have been examined in detail and decided to place the proposal before the Board for considering the request of the individual for ratification for passing the Tamil Language Test beyond the period of two years and for extension of time for passing

the said test. Accordingly, the said proposal has been placed before the Board held on 28.09.2022. The Board in its 108<sup>th</sup> meeting held on 28.09.2022 has examined the subject carefully and approved the proposal and the decision of the Board is as follows:-

*"The Board after detailed deliberations approved the proposal taking into consideration the Covid 19 constraints and as a last chance give permission to pass the test till May 2023. The Board further directed that beyond May 2023, no extension of time should be sought. The Board also directed that steps have to be taken for termination of those who have not passed the test by May 2023 by issuing appropriate notice and by following due process of law/ procedure."*

5. Based on the above direction of Board, the following orders are issued :-

- (i) *The following Assistant Engineers/Electrical/ Mechanical and Civil who have passed the Tamil Language Test beyond the stipulated period of 2 years be ratified by relaxing the Regulation 91 (3) (b) and permitted to continue in Board service.*

If they have not passed the Tamil Language Test on or before May 2023, further extension of time will not be granted and their appointment will be terminated.*

6. The Chief Engineers/Superintending Engineers concerned are directed to follow the above instruction without fail and if any of the Assistant Engineers mentioned above fail to pass the test within the extended period viz., May 2023, no extension of time should be sought for and also directed that necessary steps have to be taken for terminating the candidates those who have not passed the test before May 2023, by issuing appropriate notice and by following due process of law/procedure.

7. The receipt of the Tamil Nadu Generation and Distribution Corporation Limited proceedings shall be acknowledged.
