As per the orders made in W.P. No.15817 of 2019 and the representation of the employees and the Unions to select and appoint the eligible left out persons in the Internal Selection conducted during the year 2017-19 to the post of Assistant Engineer/ Electrical based on their B.E./B.Tech. Degree obtained from Vinayaka Missions University, Salem through Part Time Mode based the issue has been examined in detail along with the applications received from the employees to the call for dated 12.07.2017.

2) In its order dated 29.07.2021 in W.P. No.15817 of 2019, filed by Thiru.M.Rajasekaran and 4 others, the Hon'ble High Court of Madras has directed to include the name of the petitioners in the Internal Selection conducted during 2017-19 and issue posting orders to the petitioners. The petitioners in the above said Writ Petition have studied B.E. Degree in VMRF, Salem through Part Time mode. Based on the Hon'ble High Court's order, the request of the petitioners in the above said Writ Petition were examined and 4 eligible petitioners were selected for appointment to the post of Assistant Engineer/ Electrical by selection orders issued on 28.05.2019 as per their eligibility, selection criteria, merit and communal roster.

3) The TANGEDCO has decided to consider the request of similarly placed B.E. graduates who obtained their degree by part time mode from Vinayaka Missions University, Salem to the post of Assistant Engineer/ Electrical by Internal Selection as per the eligibility, selection criteria, merit and communal roster. On examination the request of the employees detailed in the Annexure-III to this order to examine and select them to

the post of Assistant Engineer/ Electrical called vide Letter No.058434/1061/G.55/G.551/2017-1, dated 12.07.2017 are not feasible of compliance for the following reasons:

- i) The number of candidates to be selected in the internal selection conducted during the year 2017-19 based on the TNEB Service Regulation (for maintaining 1:1 ratio between Direct and Internal Selection of Assistant Engineers) is 272 posts only. The percentagewise ratio to be adopted between the various disciplines of B.E./B.Tech by Per.(FB) TANGEDCO Proceeding No.12 dated 21.08.2014 from among the applicants while considering for Internal Selection is 91% for EEE, 7% for ECE/IE, 2% for CSE/IT. Hence, the number of candidates to be considered for selection under EEE discipline is 248 only.
- ii) In the Internal Selection called for during the year 2017, the last selected candidate (selected by U.O. Dated 28.05.2019) under EEE discipline belonging to the communities such as OC, BCO, MBC/DC and SC have joined in the erstwhile TNEB now TANGEDCO and have completed the B.E./B.Tech. during the year as tabulated below:

4) In view of the above, the claim of the individuals in the Annexure-III for selecting them to the post of Assistant Engineer/ Electrical by Internal Selection called vide Letter No.058434/1061/G.55/ G.551/2017-1, dated 12.07.2017 and selected vide U.O. dated 28.05.2019 is not feasible of compliance.
