Sub : TANGEDCO - COVID-19 claims – Employees and their eligible family members (including spouse) – Settlement of COVID -19 claims on reimbursement basis under Non-critical care treatment taken in Non-network hospitals which is not covered under New Health Insurance Schemes – Sanction from Corpus Fund – Orders issued by the Government copy – Communicated.

In the Government Order first cited, the Government have issued orders including a new package for treatment of Critical and Non-Critical care for COVID-19 positive cases covered under NHIS for employees and that the United India Insurance Company Ltd., shall make payments to all COVID positive cases that receive Critical care as per the package rates for existing procedures covered under the NHIS, subject to a ceiling of Rs.4 lakhs.

2. In respect of Non-Critical care COVID-19 positive cases, the Government have authorised the United India Insurance Company Ltd., to form separate Corpus Fund of Rs.5 Crore for COVID 19 treatment in empanelled hospitals under NHIS for employees. It was also ordered that United India Insurance Company Ltd., shall make payments for Critical care for COVID positive cases even in non-empanelled hospitals on these treatment will come under the emergency clause of the NHIS after getting orders from the District Level Empowered Committee on approved cases. In respect of Non-Critical care, it was ordered to restrict the treatments to empanelled hospitals for the benefit of patient welfare. The said Government Order has been adopted in TANGEDCO vide Proceedings second cited.

3. In the reference third cited, the Government among other things have issued orders for reimbursement of the eligible expenses incurred by the Government Employees and their eligible family members under Non-Critical COVID care for the treatment taken in Non-net work hospitals by creating corpus funds for Rs.4.00 Crore (Rupees four crore only) for Government Employees and their eligible family

members considering the welfare of the Employees. **It has also been ordered that the Government Employees who have already taken treatment for Non-critical COVID care in Non-empanelled Hospitals from 01.03.2020 to till date may be directed to submit their claims for reimbursement by applying to the Commissioner of Treasuries and Accounts Chennai.**

4. All the Chief Engineers, Superintending Engineers and other officers are therefore requested to communicate the above Government order to all the officials/ employees working under their control and direct the employees to send such proposal through the officers concerned to the following address along with the documents as detailed below:-
