PROCEEDINGS:-

In the Proceedings first cited, orders were issued for delegation of powers to the Directors of TANGEDCO and TANTRANSCO for sanctioning the proposals for provision of Landline Telephones and CUG SIM Cards to the eligible Officers of TANGEDCO/ TANTRANSCO. Accordingly, the Chief Engineers/ Superintending Engineers are forwarding their proposals to the Chief Engineer/ Personnel, seeking approval for providing Landline and CUG SIM Cards to the eligible incumbents of the newly sanctioned posts in the newly formed Offices/ Sub-Stations. After careful examining the said proposals, necessary orders are being issued by the Chief Engineer/ Personnel after obtaining the approval from the respective Directors of TANGEDCO/ TANTRANSCO, with monthly ceiling limit as ordered in the Proceedings second cited.

2) Now, certain Chief Engineers/ Superintending Engineers have requested to sanction the CUG SIM Cards instead of Landline Telephone, stating that their offices/ Sub-Stations are located in the very remote areas/ hill sides and where BSNL services is not feasible.

3) After careful consideration, the CMD has ordered that the CUG SIM Cards (BSNL) may be provided instead of providing Landline telephones to the eligible Officers working in the offices located in remote/ hill side areas where the Landline facilities are not available/ could not be provided, for official communication purpose.

4) The receipt of the Board's Proceedings shall be acknowledged.
