Considering their requests, the Wage Revision Committee has decided to give the final proposal to the Trade Unions/Associations for submitting their views for amicable settlement of Wage Revision. Accordingly, the Wage Revision Committee's final proposal is annexed to this letter for perusal of the Trade Unions.

ANNEXURE

TANGEDCO'S PROPOSAL ON WAGE REVISION WITH EFFECT FROM 01.12.2019.

PAY

The Revision of Wages to the Employees/Officers of TANGEDCO/TANTRANSCO is due from 01.12.2019. Taking into consideration, the demands put-forth by the Unions/ Associations on Revision of Wages and the present financial position of TANGEDCO/TANTRANSCO and all other relevant factors, the Wage Revision Committee proposes to increase the basic pay of the Employees/Officers by 6% with effect from 01.12.2019 as per the level of pay in the pay matrix. Consequent on the Wage Revision with effect from 1.12.2019, the date of next annual increment will not be changed.

SERVICE WEIGHTAGE

The Wage Revision committee also proposes to permit one Service Weightage increment @3% to all the employees who have completed 20 years of service as on 1.12.2019. No service weightage shall be sanctioned to the Class I & II Officers.

WORK LOAD

- 1. The existing work norms and Staff pattern of the employees of TANGEDCO/TANTRANSCO, will be continued until the new work load settlement is made after due discussion with the Trade Unions/ Associations.
- 2. In order to optimize the employee cost as per Industry Standards, TANGEDCO and TANTRANSCO shall discuss the right-sizing the manpower along with the Revision of Work Norms and Staff Pattern. Till decision on Right sizing is taken, no new posts will be created.
- 3. The work Load will be discussed separately and settlement will be made within three months.

REVISION OF HRA, CCA, SPECIAL PAY AND OTHER ALLOWANCES

It is proposed to continue the existing slab rates of House Rent Allowance, City Compensatory Allowance, Special Pay and all other allowances to the Employees/Officers working in TANGEDCO/TANTRANSCO till the State Government revises the allowances.

With regard to the revision of other allowances, it is proposed to form a Committee to examine the issue and finalize the same based on the recommendations of the Committee.

THE FREQUENCY OF WAGE REVISION FOR OFFICERS

For Class I & II service, the wage revision is considered this time based on the request of various Unions/Associations. However, the wage revision for Class I & II Officers shall be considered only on par with State Government officials in future.

FIXATION

- 1. The fixation of pay will be considered with effect from 01.12.2019/on the date of option.
- 2. The Monetary benefit will take effect from 01.04.2022.
- 3. 50% of the arrears will be paid in cash. The remaining 50% shall be paid after a period of one year from the date of disbursement of first instalment.

SELECTION GRADE AND SPECIAL GRADE

The existing scheme of allowing two increments for movement to Selection Grade/Special Grade on completion of 9/20 years will be continued.
