Sub: TANGEDCO – Secretariat Branch – Request to render continuous treatment without insisting on the payment from TANGEDCO Employees towards Departmental Accident (Electrical/Mechanical) – Payment of balance amount – Intimation – Sent.

It is brought to the notice that Thiru S.Chandresekaran, Line Inspector, office of the Assistant Engineer/O&M/Belagondanpally Section, Krishnagiri who met with the departmental mechanical accident on 29.07.2023 has been admitted in Ganga Hospital, Coimbatore for treatment.

2. I am to inform that among other things, orders have been issued in Memo(Per). No.55289/A17/A172/2013-1, dated 23.08.2013 as far as the Electrical/ Mechanical accident is concerned immediate and urgent treatment is required in order to safeguard the life of the employee/officers in case of emergency conditions and the employees/officers will not be in a position to pay the medical expenses to the hospital. Hence, the Executive Engineers concerned were directed to give letter to the hospital authorities to the effect that the entire medical expenses incurred for the treatment of departmental accident to the officers/staff who met with electrical/ mechanical accidents while on duty will be reimbursed by the TANGEDCO.

3. I am therefore to request you to extend the treatment to the employees of TANGEDCO who met with departmental accidents on accepting the letter given by the Executive Engineer concerned and the TANGEDCO will settle the balance cost of the treatment over and above the amount sanctioned by the Insurance Company, by following the due process.
