PROCEEDINGS:

The Board of TANGEDCO has accorded in principle approval vide Proceedings first read above for formation of 10 Nos. of new O&M Distribution Divisions in various Distribution Circles including the 2 new Divisions at Pallavaram and Sholinganallur by trifurcating the existing Tambaram Division in Chennai Electricity Distribution Circle/ South-II. Accordingly, necessary proposal has been received from the Superintending Engineer/ Chennai EDC/ South-II and the said proposal has been examined in detail and placed before the Board.

2) The Board of TANGEDCO has approved the proposal as below:-

- i) Formation of 2 new O&M Divisions at Pallavaram and Sholinganallur by trifurcating the existing Tambaram Division in Chennai Electricity Distribution Circle/ South-II by reorganizing the respective Sub-Divisions under the new Divisions as follows :-
