Establishment – TANTRANSCO – Merging of GCC and CDC/TANTRANSCO/Chennal and redeployment of certain posts from the Office of Superintending Engineer/CDC-I and Superintending Engineer/CDC-II/Chennal to the newly formed P&C Circles at Thiruvalam and Neyveli - Orders - Issued.

PROCEEDINGS:-

In the proceedings second read above, among others, orders were issued for formation of 2 Nos. new P&C Circles at Thiruvalam and Neyveli.

- 2. The Director (Transmission Projects)/TANTRANSCO has proposed to merge and re-deploy certain posts in the Office of the Chief Engineer/ Transmission Projects-I/Chennai so as to streamline the existing works as follows:
 - i. At present in Chennai city area EHT overhead lines AIS Sub-station works has been executed by GCC circle and UG Cable, GIS Sub-station works executed by CDC circle. To make execution of entire scheme works by single agency, it is inevitable to merging and re-deploying certain posts.
 - ii. To allocate the work area-wise to each GCC circles for making beneficiary to the betterment of management.
 - iii. The unequal volume of work has been proposed to equalize to the GCC circles.
 - iv. The volume of work of CDC-I and CDC-II circles are reduced and lesser.

- v. To merge the following Circles/TANTRANSCO:
 - a. Superintending Engineer/GCC-I/Chennai and Superintending Engineer/CDC-II/Chennai
 - b. Superintending Engineer/GCC-II/Chennai and Superintending Engineer/CDC-I/Chennai
- vi. To redeploy the certain posts from Superintending Engineer/CDC-I/Chennai to Superintending Engineer/P&C/Thiruvalam and Superintending Engineer/CDC-II/Chennai to Superintending Engineer/P&C/Neyveli.
- 3. The proposal has been examined in detail and it has been decided to accept the same. Accordingly, it is hereby ordered that the following posts of Superintending Engineers last continued in the Memo. first read above be merged as mentioned in column (2) and named as mentioned in column (3) of the Table below. Further, the redeployment of the posts last continued in the reference third read above to the newly formed P&C Circle along with the incumbents under the control of the Chief Engineer/Transmission Projects-I/Chennai as indicated in Column (4 & 5) of the Table as detailed below:
