Memorandum No.40489/A17/A172/2023-1, dated 02.12.2023.

Sub: Tamil Nadu Government Employees' Special Provident Fund-cum-Gratuity Scheme-1984 Interest Calculation – Clarification issued by the Government – Adoption in TANGEDCO – Orders issued – Misinterpretation of the orders – Difference amount for the past cases – Requested – Further Clarification - Issued.

Based on the clarifications issued by the Government in the letters first and second cited, necessary clarificatory orders have been issued to all the Pension Sanctioning Authorities to the effect that the interest for TNEB Employees' SPFG-1984 be calculated as per General Provident Fund rate of interest applicable from time to time by adding interest amount to the principal, compounded annually, duly enclosing a Working Sheet for easy understanding and uniform adoption by all the Pension Sanctioning Authorities – vide Proceedings third cited.

2. It has been brought to the notice that after issuance of the aforementioned Proceedings, several pensioners are sending the applications to the concerned Pension Sanctioning Authorities for revising the TNEB Employees' SPFG-1984 amount already sanctioned to them at the time of retirement by comparing the amount sanctioned to them, with the amount shown in the Working Sheet annexed to the said Proceedings and to sanction the difference amount to them. After detailed examination, it has been decided to issue a suitable clarification to all the Pension Sanctioning Authorities in this regard.

3. Accordingly, it is clarified that;

- (i) the orders issued in the reference third cited, took effect from the date of issue of orders (i.e. 03.08.2023).
- (ii) the past cases need not be reopened.

- (iii) the working sheet annexed to the Proceedings third cited, is a model illustration to be followed while making calculation of interest under TNEB Employees' SPFG-1984 by all the Pension Sanctioning Authorities to maintain uniformity in future cases only.

4. Any deviation in this regard will be viewed seriously.


