PROCEEDINGS:-

In the proceedings first read above, among others, orders were issued delegating the powers to the Chairman and Chief Engineers for sanction of Legal Fees under the heading "Law Charges".

- 2. In the proceedings third read above, among others, following the orders of the Government in the reference second read above, general orders were issued on various fees payable to Advocates, Standing Counsels and Senior Law Officers engaged for the organization cases.
- 3. In order to further streamline the functioning of the TANGEDCO as a whole and to provide immediate response to issues requiring immediate decisions, it is necessary for senior officers and certain officers in Class-I Service level to be delegated with powers to discharge their duties efficiently. Therefore, the Legal Adviser/TANGEDCO has suggested to revise the existing financial powers to officers for sanction of Legal Fees and Law Charges.

4. The TANGEDCO Board in its meeting held on 18.11.2023 has approved the revision of delegation of powers to officers for sanction of Legal Fees and Law Charges. Accordingly, it is hereby ordered that the delegation of existing financial powers relating to Legal Fees and Law Charges be revised to the
