

Establishment – TANGEDCO – Avoiding creation of artificial vacancies to accommodate the officers by promoting them at the time of their retirement – Certain guidelines issued by the Government – Adoption in TANGEDCO – Orders issued – Amendment to Tamil Nadu Electricity Board Service Regulations – Issued.

PROCEEDINGS:

The Government in G.O. first read above, had issued certain guidelines in connection with avoidance of creating artificial vacancies to accommodate officers by promoting them at the time of their retirement. The said orders have been adopted in TANGEDCO - vide Proceedings second read above. A proposal for making suitable amendment to the TNEB Service Regulations in this regard, has been considered and approved by the Board of TANGEDCO.

<u>2.</u> Accordingly, in exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited

(formerly Tamil Nadu Electricity Board) makes the following amendment to the Tamil Nadu Electricity Board Service Regulations:-

AMENDMENT

In the said Regulations, in regulation 98, under sub-regulation (1), after clause (a), the following proviso shall be inserted:

"Provided that no appointment shall be made by promoting persons at the verge of retirement by creating artificial leave vacancies by the seniors in order to accommodate juniors in such artificial vacancies (including leave vacancies, upgradation of posts and temporary promotions) by promoting them on the day of retirement or few days prior to the date of retirement thereby allowing them to get monetary benefits without completing full service."
