**PROCEEDINGS:-**

In the Board's Proceedings first read above, the TANGEDCO had constituted a Committee to negotiate with the Unions/Associations on revision of pay matrix, work allocation and staff pattern to take effect from 1-12-2019.

2. In the Memo. second read above, two officers representing from Government in Finance and Energy Departments have been included in the Wage Revision Committee as Members in order to negotiate with Unions/Associations.

3. It has been decided to form Working Groups consisting of the Officers of TANGEDCO to assist the Wage Revision Committee to achieve economy in expenditure by rationalizing and revising the workloads in respect of the areas, which have already been covered by Work Load settlements. Accordingly, the following four Sub-Committees be constituted and the Officers mentioned in each committee are nominated as Members of the Sub-Committees to suggest suitable revised workload norms and to submit a report:-
