

ESTABLISHMENT - TANGEDCO-REDESIGNATION OF CERTAIN JUNIOR ENGINEER MECHANICAL I GRADE WHO HAVE COMPLETED 15 YEARS AS JUNIOR ENGINEER MECHANICAL I GRADE AS ASSISTANT EXECUTIVE ENGINEER/MECHANICAL (NON-INDEPENDENT) - ORDERS ISSUED.

## Proceedings:

The Junior Engineer/Mechanical I Grade who have joined during the year 1999 to 2006 have represented that they are working as Junior Engineer/Mechanical I Grade for the past 15 years and requested to re-designate them as Assistant Executive Engineer/Mechanical (N.I.)

Their representations have been examined and after careful consideration, it is hereby ordered that the list of 96 persons (Ninety Six) holding the post of Junior Engineer Mechanical I Grade in TANGEDCO as per Annexure be Re-designated as Assistant Executive Engineer/Mechanical (N.I.) without Monetary (or) any other benefit as a one time measure whatsoever with effect from the date of issue of this B.P. subject to the following conditions.

- i) No new sub-divisions shall be created to accommodate them, and they have to perform the work of Junior Engineer Mechanical I Grade and work under AEE/Mechanical concerned till they get promotion as Assistant Executive Engineer/ Mechanical in the regular vacancies, according to their inter-se-seniority and as per the orders in force.
- ii) The benefit of Re-designation shall be personal to them. The above Re-designated posts will be converted automatically as Junior Engineer/Mechanical I Grade at the time of the incumbents holding the Re-designated post get regular promotion in their turn or at the time when they get retirement or get relieved from the post, whichever is earlier.

- iii) On transfer from one post of Junior Engineer Mechanical I Grade to another post as well, the Re-designation as Assistant Executive Engineer/Mechanical (N.I.) shall continue. The Re-designation ordered shall not apply to those who are on Extra Ordinary Leave, unauthorized absence, suspension, voluntarily retired/resigned, under going punishment against whom major disciplinary proceedings have been contemplated and criminal charges are pending.
- iv) The Re-designated Assistant Executive Engineer/ Mechanical (N.I.) shall not seek request/demand any monetary benefit (or) any other whatsoever by virtue of this order.
- v) The Re-designation so ordered shall not confer any power/privilege attached to the post of regular Assistant Executive Engineer/Mechanical and they shall continue to exercise the powers of Junior Engineer Mechanical I Grade only wherever they are posted for all purpose and work under Assistant Executive Engineer/Mechanical concernred.
- vi) The Re-designation is ordered as a special case and it shall not be taken as a precedent in future.
- vii) Undertaking shall be obtained from the individuals that they will not claim any benefit other than the Re-designation as AEE/Mechanical (N.I.).
- viii) Further promotion will be given based on the existing Assistant Engineer/Junior Engineer Mechanical I Grade ratio adopted for regular Assistant Executive Engineer/Mechanical promotion
