

<code>PENSION – Dearness Allowance to the Pensioners and Family Pensioners – Revised rates of Dearness Allowance from 1^{st} January, 2023 – Adoption of Government Orders – Orders - Issued.</code>

READ:

1. (Per) FB TANGEDCO Proceedings. No.28 (SB), dated 04.11.2022.

2. G.O.Ms.No.10, Finance (Pension) Department, dated 06.01.2023.

PROCEEDINGS:

In the Proceedings first read above, among other things, orders were issued allowing 34% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.07.2022.

<u>2.</u> In the Government Order second read above, orders have been issued revising the rate of Dearness Allowance from **34% to 38%**, payable to the Pensioners/Family Pensioners of the Government with effect from **1st January**, **2023**. It has been decided to extend the same benefit to the Pensioners/Family Pensioners of TANGEDCO.

<u>3.</u> Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of TANGEDCO, be paid Dearness Allowance with effect from 1^{st} January, 2023 at the following rates:-

Date from which	Revised rate of Dearness Allowance (per
payable	month)
1 st January, 2023	38% of Basic Pension/Family Pension.

<u>4.</u> The increased rate of Dearness Allowance from **34% to 38%**, ordered in para-3 above, shall be paid to the Pensioners/Family Pensioners along with the pension/family pension from the month of **January**, **2023**.

5. The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

<u>6.</u> In the case of divisible Family Pension, the Dearness Allowance shall also be paid proportionately.
