In the Proceedings first, second and third cited, orders have been issued for the selection of 9613 persons in the post of Gangman (Trainee) through the direct recruitment and allotted to the various circles of TANGEDCO.

- 2) In the Proceedings 6th cited, orders have been issued to the effect that the candidates appointed by direct recruitment will be eligible for request transfer within the circle after completion of one year service and eligible for request transfer after completion of two years for request transfer beyond the circle from the appointed station.
- 3) Several Unions/Individuals have represented that the request transfer of Gangman (Trainee) as two years stay in the Station affect the survival of the individual. Hence, they have repeatedly requesting to transfer them to their native places.
- 4) The said requests have been examined in detail and decided to consider the request of the individuals to transfer them to the needy places. Accordingly, it is hereby ordered that the request made by the individuals in the post of Gangman (Trainee) to transfer them in the needy places be considered without insisting the conditions stipulated in the Proceedings 6th cited. Hence, the individuals who require transfer to their native places/needy places may be directed to submit their request

to the Chief Engineer/Personnel for issuing suitable transfer orders through proper channel within 10 days for considering their request according to their seniority.

5) The order shall come into force with immediate effect.
