Establishment – TANTRANSCO – Formation of a new Hotline division along with new Special Hotline Vehicle at Korattur and sanction of additional staff strength to each Hotline Section by redeployment of posts - Orders – Issued.

PROCEEDINGS:-

The Hon'ble Minister for Electricity, Prohibition and Excise has made the following announcement on the floor of the Tamil Nadu Legislative Assembly on 26.04.2022 :-

“மிக உயர் மின்னழுத்தம் கொண்ட மின் பாதைகளில் எவ்வித மின் நிறுத்தமுமின்றி மின்னூட்டம் உள்ளபோதே பணியாளர்கள் பணிபுரியும் வகையில் ஏற்கனவே உள்ள கோட்டங்களுடன் வரும் நிதியாண்டில் (2022-23) புதிய Hot Line கோட்டம் ஒன்று உருவாக்கப்படும்”.

2. Based on the above announcement, an administrative approval has been accorded for formation of 1 no. new Hotlines division at Korattur along with 1 no. new special Hotline vehicle and additional staff strength to each existing Hotline Section by redeployment of posts in the reference first read above.

3. The Chief Engineer/System Operation has stated among others that, at present, there are five Hotline sub-division functioning in the State viz. Chennai, Coimbatore, Thiruvallam, Madurai and Trichy. These sub-divisions have not been provided with sufficient staff. As the live line maintenance techniques completely eliminated the costly maintenance shutdowns and forced outages by the way of preventive maintenance works, which improves the availability of EHV

transmission lines and sub-stations, an additional staff strength in each Hotline Section is required so as to carry out the Hotlines works effectively. In fine, he has requested to issue suitable orders for sanctioning of posts by re-deployment, vehicle and other safety amenities to the Hotline Sections including the new Hotline Division.

4. The proposal of the Chief Engineer/System Operation has been examined in detail and decided to accept the same. Accordingly, the following orders are issued :-

- (i) The posts last continued in the Memo. (Per.) No. 050695/118/G.36/G.361/2021-2, dated 03.02.2022 among others the following two posts continued and these posts be merged and renamed as mentioned in column 3 of the table below :-

- (ii) After merging the posts as mentioned above, the post of Executive Engineer/Operation/CMRL/Koyambedu SS be re-designated as Executive Engineer/Hotlines and be re-deployed to the said post to the newly formed Hotline Korattur Division along with the incumbent. The said post is comes under the administrative control of Superintending Engineer/Chennai EDC/West and technical control of Superintending Engineer/Operation/Chennai/North with the vehicle/CUG No.

- (iii) The following additional posts be re-deployed to each of the five existing Hotlines Sub-division :-

- (v) a. One new special Hotline vehicle be provided for Hotline division at Korattur.
- b. Hiring vehicle (Jeep) to the three Hotline sections (Chennai, Madurai and Thiruvallur) be provided for carrying out inspection of Hotline works.
- (vi) a. The following safety amenities for the Hotline trained officers and staff be provided for every year instead of once in two years as ordered in the (Per) B.P. (Ch) No.90 Adm. Br. dated 05.03.2007.

- b. The value of accident policy insurance for the hotline trained officers and staff be enhanced from Rs.15,00,000/- to Rs.50,00,000/- as ordered in the (Per) FB TANGEDCO Proceedings No.29 SB dated 05.11.2016.
- (vii) Necessary orders in respect of re-deployment of posts as ordered in para-4 (iii) & (iv) above will be issued separately by the Office of the Chief Engineer/Personnel/Administrative Branch/Chennai.
5. This order shall take effect from the date of issue of order.
