Sub: TANGEDCO – Vigilance Cell – Dispensing the procedure of sought for Vigilance Clearance in respect of Class I Officers (in the rank of Executive Engineer and equivalent rank) from Vigilance Cell, Secretariat Branch - Instructions – Issued.

In the Proceedings cited, instructions have been issued with regard to issue of retirement orders permitting the individual on attaining the age of Superannuation in the prescribed format (**Annexure-I of the Proceedings**).

2. It has been clearly mentioned in the Proceedings cited, among others, that;

*"in respect of Class I Officers, the Secretariat Branch shall issue a retirement order permitting the individual on attaining the age of superannuation in the prescribed format".*

3. **While the orders are like so**, it is observed that in the recent past, Vigilance Clearance is being sought for from the Chief Engineers and Superintending Engineers in respect of the Class I Officers (in the rank of Executive Engineer and equivalent rank) working under their control. Since, retirement orders are issued to all the Class I Officers, for both, Technical and Non-Technical (including Executive Engineer and equivalent rank) from the Secretariat Branch, TANGEDCO after obtaining approval from the Chairman Cum Managing Director, TANGEDCO, **there is no need to sought for Vigilance Clearance, alone, separately from the Vigilance Cell, S.B., TANGEDCO in respect of the above said Officers.**

4. Hence, all the Chief Engineers, Superintending Engineers and other Competent Authorities are hereby **instructed that not to send such kind of Vigilance Clearance proposal to the Director General of Police/Vigilance, TANGEDCO**, in future, seeking vigilance clearance in respect of the Class I Officers (Both Technical and Non-Technical) in the rank of Executive Engineer and equivalent rank. Suitable instructions shall also be issued to the officials concerned, who is dealt with the subject.


