Establishment – Thermal Power Stations - Ash Handling System/Wing - Restricting the maximum period of service to be rendered by all the officials/employees to 3 years - Orders – Issued.

READ:

1. Ministry of Environment, Forest and Climate change/Government of India, Notification dated 31.12.2021.
2. Minutes of 111th Board Meeting of TANGEDCO held on 08.02.2023

PROCEEDINGS:

In the Government of India's Notification first read above, it has been notified among others that in Thermal Power Stations, the entire accumulated Legacy Ash is to be disposed within 10 years. Otherwise, a huge amount of penalty deemed fit is likely to be imposed at the end of every cycle period in all Thermal Power Stations. Further, periodical reviews are being conducted to achieve the same.

2. The above notification of Government of India has been examined in detail and it is found that while implementing the above orders and in order to avoid the accumulation of wet ash in the ash dykes of the respective Thermal Power Station, it is mandatory to dispose the entire generated ash (ESP ash & bottom ash) without slurring into the ash dyke by incurring additional expenditure. Further, the utilization of the services of officials/employees who are working in the Ash Handling System/Wing for a longer period, would result in loss of enthusiasm among them. To remove such difficulties, a proposal for restricting the period of service of all the officials/employees upto the cadre of Executive Engineer working in the Ash Handling System/Wing of Thermal Power Stations to Three years maximum in their entire service in TANGEDCO, has been placed before the Board of TANGEDCO in its meeting held on 08.02.2023 and the same has been approved by the Board of TANGEDCO.

3. Accordingly, it is hereby ordered that no officer/employee in all cadres upto the level of Executive Engineers, shall be allowed to work in Ash Handling System/Wing of the Thermal Power Stations beyond 3 years in his/her entire service in TANGEDCO.

4. The authorities who are empowered to order transfer and posting of the officials shall ensure the above orders are followed in good spirit.
