Wholehearted thanks to the respected Chairman cum Managing Director for considering our Sangam's genuine plea and doing the needful in issuing of Junior Engineer / Electrical, Grade II to Grade I promotions, benefitting not just the individuals but the Board also.

We hereby submit a similar plea in Technical Assistant/Electrical to Junior Engineer / Electrical, Grade II promotion for favourable consideration please.

 Based on our Sangam's persistent representation, Suitability report was called among 1077 Technical Assistants for promotion to the post of Junior Engineer / Electrical, Grade II vide reference – 2 cited above with the crucial date of 20.03.2022.

- Particulars were received from the field and as per that, not even 10% of the called for persons among 1077 are suitable on the crucial date.
- Recently amended Service Regulations 94 and 98 of Tamilnadu Electricity Board Service Regulations, which were issued vide reference - 1 cited, increasing the length of service eligible for promotions, breaking the six decade old practice making most of the persons ineligible.
- Numerous representations had been made by our Sangam as cited in references for withdrawal of this amendment order which has been issued in haste. Respected Chairman cum Managing Director too had assured us of a positive settlement in this matter when it was brought up during the discussion with our Sangam on 07.10.2021.
- Citing delay in withdrawal of the cited order under reference 1 we had even requested a 1 time relaxation for the current panel from the recent amendment.
 - None of our plea had borne fruit and the matter is still pending consideration.
- Presently if the panel is processed as such roughly around 100 odd persons only are going to be benefitted with promotions which wouldn't be fruitful for the Board leave alone the benefit of the individuals.
 - Most of the not selected persons are falling short of a couple of months for eligibility to promotions.
- Presently almost a year has elapsed since call for of this panel and the next crucial date of 20.03.2023 has crossed.
- If the crucial date of the calling for is changed from 20.03.2022 to 20.03.2023 more individuals will be benefitted and also will result to more benefit to the Board considering the huge vacancies in the post of Junior Engineer / Electrical Grade II.

We earnestly pray the respected Chairman cum Managing Director to consider our genuine plea and do the needful for changing the crucial date from 20.03.2022 to 20.03.2023 benefitting not just the individuals but the Board also, thereby keeping up the assurance given to us, and thus render justice please.
