

PENSION – Dearness Allowance to the Pensioners and Family Pensioners – Revised rates of Dearness Allowance from 1st April, 2023 – Adoption of Government Orders – Orders - Issued.

PROCEEDINGS:

In the Proceedings first read above, orders were issued allowing 38% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.01.2023.

<u>2.</u> In the Government Order second read above, orders have been issued revising the rate of Dearness Allowance from **38% to 42%**, payable to the Pensioners/Family Pensioners of the Government with effect from **1st April**, **2023**.

<u>3.</u> It has been decided to extend the same benefit to the Pensioners/ Family Pensioners of TANGEDCO. Accordingly, it is hereby ordered that the Pensioners/ Family Pensioners of TANGEDCO, be paid Dearness Allowance with effect from 1st April, 2023 at the following rates:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st April, 2023	42% of Basic Pension/Family Pension.

<u>4.</u> Consequent on increase in the rate of Dearness Allowance from **38% to 42%**, the arrears for the month of **April 2023**, as ordered in Para-3 above, shall be paid to the Pensioners/Family Pensioners along with the pension/family pension from the month of **May 2023**.

5. The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

6. In the case of divisible Family Pension, the Dearness Allowance shall also be paid proportionately.
