PROCEEDINGS:

In the reference I to V read above, Out of 10,000 newly created posts of Gangman, 9613 persons were selected for Gangman (Trainee) with certain conditions and on consolidated wages of Rs.15,000 per month with a training period of 2 years and after completion of training be placed as regular Gangman in the time scale of pay 16,200-51500.

2) The Superintending Engineer/Dindigul, Coimbatore/ Metro, Nagai Electricity Distribution Circles in the references VI to VIII read above, have requested certain clarification on the eligibility of the Leave and other Benefits to the newly created post of Gangman.

3) Some of the Unions have also represented on the above issue and requested for clarification.

4) The issue has been examined in detail and it is hereby ordered that the Gangman who are in regular time scale of pay are eligible for the following leave and other benefits, applicable to other employees of the Board.

- i) Casual Leave, Earned Leave & Medical Leave
- ii) Special Casual Leave
- iii) Family Security Fund Scheme (FSFS)
- iv) Travel Allowance
- v) Festival Advance
