Sir/Madam,

Sub: Recruitment (Internal) – Class III Service - Filling up of Vacancies of Junior Engineer/Civil II Grade by Internal Selection – proposals of qualified employees – Called for.

It is proposed to call for application from the qualified employees of TANGEDCO/TANTRANSCO to fill up vacant post of Junior Engineer/Civil II Grade by Internal Selection as per Service Regulations.

- 2) The eligibility conditions are as follows:
 - i) The employees who are working in Regular Work Establishment and Senior Draughtsman, Draughtsman including Assistant Draughtsman possessing Diploma in Civil Engineering or as referred to in Regulation 92 Annexure I and Regulation 94 Annexure III.
 - The employees who have passed Diploma through Distance Education from any Universities are not eligible for Internal Selection.
 - iii) As per Regulation 95(b) of TNEB Service Regulations, the employees who are approved probationer or probationer are eligible to apply.
 - iv) The employees who are involved in D.P./undergoing punishment on the date of notification are not eligible.

- v) The employees who have the requisite qualification prior to 07.06.2022 as per (Per.) FB TANGEDCO Proceedings No.5, dated 07.07.2022 alone are eligible to apply.
- vi) The employee must possess adequate knowledge in Tamil as stipulated in (per.) FB TANGEDCO Proceedings No.42, dated 28.11.2019.
- vii) Part time conservancy workers, Ex-Servicemen appointed as watchmen by direct recruitment, Gangman are not eligible to apply.
- 3) The selection will be made on merit according to the rule of reservation order as per G.O.Ms.No.65, P & AR (K) Department dt. 27.05.2009 and as per Regulation 95(b) of TNEB Service Regulation.
- 4) I request you to give wide publicity by displaying a copy of this communication in the Notice Board in the respective offices and issue circulars to the offices under your control instructing eligible willing employees to apply via online in the TANGEDCO intranet URL: http://192.168.150.75/openbd/ISJE_CIVIL between 15.11.2023 (10.30 A.M.) 14.12.2023 (05.30 P.M.) The eligible willing employees who have applied for internal selection may be instructed to submit the printout of the application downloaded from the website along with the copies of T.C. and uploaded documents to their office on or before 21.12.2023 failing which their online application will be automatically cancelled and will not be considered for internal selection for the post of Junior Engineer/Civil II Grade.
- 5) I request you to consolidate the above application received from the employees and verify the proposal sent by the applicants with the attested copies of certificates towards evidence of their Date of Birth, Community, Academic Qualification and a certificate for Physically challenged person if any, verify the proposal sent by the individual along with the S.R.Book/Certificates and consolidate the same and send a detailed report with all enclosures along with the genuineness of the qualification if already obtained or send the consolidate report with a remark that genuineness has been called for from the concerned authority. Further, the competent authority may then obtain the genuineness certificate from the concerned department and forward the same to this office for finalization of selection at the very earliest. The Probation of the selected applicants in the post of Junior Engineer/Civil will however be declared only as per the Secretary Memo No.68638/A18/A181/2019-1, dated 04.02.2020. The competent authority is requested to send the consolidate report along with their certification as stated in the Annexure A.
- 6) If any applications other than those eligible as stated at para 2 above are forwarded to this office without proper verification and certification it will be viewed seriously and action will be taken on the concerned Staff/Officer, in this regard.

- 7) I am also to request you to forward the consolidated proposal furnishing all the required details in complete shape to this office positively on or before 10.01.2024 without fail.
 - 8) If no qualified person is available, a NIL report should be sent promptly.
 - 9) I am to request you to acknowledge the receipt of this letter.
