I invite your kind attention to the references cited.

In the reference 8th cited, in respect of the settlement of reimbursement claims pertaining to the treatment taken **from 01.07.2021 to 30.06.2023 for employees** the time limit for the submission of reimbursement claims have been communicated.

In the reference 9th cited, the United India Insurance Company Limited has suggested certain modifications. Based on the request, the revised time line is given in the table which has to be followed.

1	Cut off date for submission of reimbursement claims by Employees (through their Head of organization).	To submit the application in the respective offices before 31.10.2023	No Change -
2	Cut off date for forwarding the reimbursement claims to United India Insurance Company Limited by the Head of Organizations.	As and when received, the concerned offices has to forward reimbursement applications to United India Insurance Company Limited immediately. Final cut off date for forwarding the reimbursement applications – Before 10.11.2023.	No Change -
3	The applications decided by the United India Insurance Company Limited as ineligible for reimbursement shall be returned to the concerned individuals informing them to place the cases in District Level Empowered Committee.	<u>As per Government Letter (Ms) No.30465/Finance(HI)/2022-1 dated: 17.09.2022</u> Settlement has to be made within a period of 30 days from the receipt of applications. If the claim is not eligible under this scheme the same has to be returned to the petitioners with the proper reason within a period of 15 days. Therefore, all in eligible claims shall be returned to the concerned individuals before 25.11.2023	Ineligible claim shall be retruned by the United India Insurance Company Limited before 15.12.2023
4	Cut off date for the submission of appeal petitions to the concerned Joint Director of Health Services for placing the claims in District Level Empowered Committee.	15.12.2023	Time limit extended up to 05.01.2024
5	District Level Empowered Committee has to be conducted for the above claims	Before 10.01.2024.	Before 31.01.2024
6	Cut off date for forwarding the claims decided in DLEC under scenario I and II payable by the United India Insurance Company Limited	Before 25.01.2024	Time limit extended up to 15.02.2024.

In this regard, the Heads of Organizations are requested to take necessary action to communicate the same to the notice of Employees working under your control and also to adhere the instructions already issued in the reference 8th cited.
