Accordingly, it is hereby ordered that the two posts of Senior Personnel Officer, Office of the Chief Engineer/Personnel/Administrative Branch last continued in the Memorandum third read above be surrendered as and when the incumbents holding the said post retire from service on superannuation/VRS or any other circumstances.
