- ii) The promotees concerned should join duty at the place posted within 2 weeks from the date of issue of this order and no modification of postings will be entertained.
- iii) If he/she fails to assume charges within 2 weeks of relief from the present station, promotion orders will be cancelled.

The Superintending Engineers concerned are directed to relieve the promotees within 15 days from the date of receipt of order, by making local arrangements without waiting for substitute and instruct them to join at the new post immediately, failing which the Officers concerned will be held responsible.
