Establishment – TANGEDCO – RWE - Request Transfer Application applied via online during January/July - Delegation of powers from Chief Engineer/Personnel to Chief Engineer concerned – Orders – Issued.

PROCEEDINGS:-

Instructions and guidelines have been issued from time to time with regard to request transfers. The existing Request Transfer guidelines for Class II to IV framed and implemented vide orders read 1st above have been followed for several years. During the year 2017, a committee was constituted to make necessary modifications and submit fresh consolidated Request Transfer Guidelines. Accordingly, Request Transfer Guidelines were issued afresh vide orders read 2nd above.

2) The Request Transfer Applications are received twice a year so that the officers/staff from Class II to IV can seek transfer to another Circle/Region. The Class II officials and Class III employees come under State seniority. However, in the case of Regular Work Establishment (RWE) employees, Circle seniority is maintained.

3) The seniority updation of RWE employees are not communicated to Head Quarters in time and hence processing the application could not be performed in time. Promotion of RWE employees is handled in concerned Circles. Operating of promotions of RWE employees at Circle and operating online Request Transfer Applications at Administrative Branch creates clash of orders. Sometimes the places to which RTA orders are issued by the Chief Engineer/ Personnel are filled up before hand by the Superintending Engineers concerned by way of promotional orders.

4) Several unions have also raised objections in processing Request Transfer Application of RWE employees by the Chief Engineer/Personnel, since accommodating employees from other circles to existing circle, compress the promotional opportunities/seniority of RWE employees working in the same circle for several years. 5) Regarding delegation of powers in the matter of Regular Work Establishment transfers instructions have been specified in Annexure – Sl.No. IV. Due to several practical difficulties encountered during implementation of Request Transfer Application applied by Regular Work Establishment employee foregoing seniority via online during January/July, the matter has been deliberately examined in detail.

6) Accordingly, the delegation of powers in effecting Request Transfer Application applied by Regular Work Establishment employee foregoing seniority via online is hereby modified as shown below: -
