PROCEEDINGS:

In the Proceedings first read above, orders have been issued for streamlining of posts in the existing 9 Regional Distribution Offices, i.e., the number of posts to be continued has been limited to 32 posts only in the 9 Regional Offices.

2) Subsequent to the above orders, the concerned Chief Engineers of the Distribution Regions have submitted proposals requesting to retain one or two more Assistant Executive Engineers (Electrical) in addition to the 6 Nos. of AEE (Electrical) as ordered in the Proceedings first cited due to the workload in technical side, by surrendering some posts at their respective Regional Offices. The said proposals of the Chief Engineers of Distribution Regions have been examined in detail and considered.

3) Accordingly, it is hereby ordered that one post of Assistant Executive Engineer (Electrical) be retained/ redeployed additionally (apart from 6 posts as ordered in Proceedings No.6, dated 10.02.2023) to the 8 Regional Offices (except Villupuram Region) as furnished below, for a period of one year from the date of utilisation of the post.

If any incumbents available in these posts, they shall be transferred to the nearby areas.
