All the Chief Engineers/Superintending Engineers/Pay Drawing Officers are hereby informed that the revision of wages w.e.f. 01.12.2019 as ordered in (Per) FB TANGEDCO Proceedings cited under reference  $1^{st}$  above (6% benefits i.e. not exceeding two cells and 3% service weightage increment and a consolidated lump sum amount of Rs.500/per month from 01.12.2019 to 31.03.2022 i.e., for 28 months) is extended to the Part Time Conservancy Workers those who were in service in TANGEDCO in the time scale of pay (4100 – 12500) as on 01.12.2019. The existing Pay matrix of Part Time Conservancy Workers shall be continued, as per the Annexure-I of this Memo.

2. As per this proceedings, no benefits/advantages other than those already granted to the Part Time Conservancy Workers will be given and the extension of the (Per) FB TANGEDCO Proceedings No.13 (SB) dt.24.05.2023 is to the effect for revision of wages and payment of arrears in 2 installments alone.
