Establishment - Class I Service – Promotion of Superintending Engineers as Chief Engineers – Superintending Engineers having less than 1 year of remaining service before retirement becomes eligible for promotion as Additional Chief Engineers with effect from the date of promotion of their junior as Chief Engineer – Dispensing with the existing condition/procedure – Amendments to Tamil Nadu Electricity Board Service Regulations – Issued.

PROCEEDINGS:

As per regulation 98(1)(b) of Tamil Nadu Electricity Board Service Regulations, the Superintending Engineer having less than one year of service before his retirement, is otherwise qualified may be considered for inclusion in the panel for promotion as Chief Engineer, but such Superintending Engineer will be appointed as Additional Chief Engineer from the date on which his respective junior is promoted as Chief Engineer and he will continue to discharge the duties and exercise the powers assigned only to the post of Superintending Engineer. The incumbents appointed as Additional Chief Engineers are permitted to draw the scale of pay for the promoted post, though they are not assigned with any additional duties and responsibilities, which has been considered as an unnecessary financial commitment to the organization. Therefore, a proposal for making amendments to the TNEB Service Regulations, dispensing with the said condition/procedure has been considered and approved by the Board of TANGEDCO.

2. Accordingly, in exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited

(formerly Tamil Nadu Electricity Board) makes the following amendment to the Tamil Nadu Electricity Board Service Regulations:-

AMENDMENT

In the said Regulations,

- (i) in regulation 98, in sub-regulation (1), under clause (b), for the expressions in sub-clause (ii), the following expressions shall be substituted:-

"The Superintending Engineers who have put in not less than 6 (Six) years of service in Class I Service alone, shall be eligible for the post of Chief Engineer, by promotion."

- (ii) the proviso under sub-clause (ii) shall be omitted.
