Tamil Nadu Power Distribution Corporation Limited erstwhile TANGEDCO has implemented centralised payment system from 01.03.2024 onwards, based on the direction of Managing Director/TNPDCL. In consideration to this the Superintending Engineers of the circle are hereby directed to instruct their concerned officials to pay the "Ex-gratia payment" in case of Fatal/Non-Fatal, Non-Departmental, Mechanical/Electrical accidents to human beings/Animals through 'Head Quarters Fund Allotment' method. This instruction shall be carried out with immediate effect.

3. This may also be noted that Head Quarters shall make 'Fund Allotment' for this category of payment based on the aforesaid table, as the case may be, till any further revision in the Order.
