## TAMIL NADU POWER DISTRIBUTION CORPORATION LIMITED ABSTRACT

### **PROCEEDINGS:**

In TNEB Service Regulation, there is a existing provision in the regulations 95(g) & 96(i) in respect of passing Electricity Departmental Account Test for those candidate who has appointed as Assistant Engineer for passing the test within 5 years and the regulation read as follows:-

"As per Regulation 96(i)a), the Assistant Engineers should pass the Departmental Test within a period of 2 years from the date of appointment. Further, as per Regulation 95 (g)

"The maximum period upto which the probation of an employee of the Board shall be extended so as to enable him to acquire the test qualification be fixed as five years. If he does not acquire the test qualification even within the maximum period of five years, he shall be reverted and the qualified eligible junior shall be considered for promotion.

If such a person has been appointed by direct recruitment and has not acquired the test qualification even within the maximum period of five years, his probation shall be terminated.

The above tests shall be conducted by the appointing authorities.

The Electricity Department Account test examination was usually conducted for the employees of TANGEDCO/ TANTRANSCO during the month of November of every year.

- 2.1 A proposal was placed before the Board in the 107<sup>th</sup> Board meeting held on 07.06.2022 to seek approval for declaration of probation to one Thiru. S.Dinesh Babu, Assistant Engineer/ Electrical/ GCC/ Coimbatore who has passed the Electricity Departmental Account Test after the prescribed time limit of 5 years and the proposal was approved by Board. Further, the Board directed to identify similar such cases and place before the Board.
- 2.2. As per the direction of Board, a detailed report have been called for from all the CE's/SE's concerned, to identify such cases who have not passed the Electricity Departmental Account Test within the prescribed time limit vide this office letter dated 04.07.2022. It was found that 3 Nos. of Assistant Engineer's/Electrical have passed the Electricity Departmental Account Test beyond the stipulated period of 5 years and also 6 Nos. of Assistant Engineers/Electrical have not passed so far even after completion of 5 years as per the Regulation and the details as follows:-

- 2.3. Out of 6 Assistant Engineers in above, Tvl.M.Senthilkumar, AE/Elecl., Virudhunagar EDC and Tmty.Kanagavalli, AE/Elecl, MTPS-I have stated the following reasons for not passed the ED test:-
  - Thiru.M.Senthil Kumar, Assistant Engineer/Electrical, Virudhunagar EDC stated that he has joined duty on 21.02.2013 as

Assistant Engineer/Electrical. He wrote the Electricity Departmental Account test for more than 5 times but he could not pass the examination due to heavy workload, mother's illness and her medical treatment and he has requested to give one more year time extension to pass the EDA test.

- Tmty.B.Kanagavalli, Assistant Engineer/Electrical, MTPS-I has stated that she has joined duty on 04.03.2016 as Assistant Engineer/ Electrical. She could not able to pass the Electricity Department Account test due to her illness and undergoing medical treatment and also preparing to pass the Tamil Language test. Now she has requested to give one more year time extension to pass the Electricity Department Account test.
- 2.4. As per the direction of Board in the 107<sup>th</sup> Board meeting held on 07.06.2022, the proposal placed before the Board in the meeting 126<sup>th</sup> held on 25.11.2024 for considering the request of the individual for ratification for passing the Electricity Departmental Account Test beyond the period of five years and granting the extension of one year time period for passing the said test. Accordingly, the Board has been examined the subject carefully and approved the proposal in its 126<sup>th</sup> meeting held on 25.11.2024.
  - 3. Based on the direction of the Board, the following orders are issued:-
  - i. The following Assistant Engineers/Electrical who have passed the Electricity Departmental Account Test beyond the stipulated period of 5 years has been ratified by relaxing the regulation 95(g) & 96(i) and approval accorded for declaring the completion of probation.
