Sub: Suitability report called for Assistant Executive Engineer / Mechanical Promotions – Inordinate delay in processing of Panel and issuing of Promotions—Kind intervention of respected Chairman cum Managing Director - requested regarding.

Based on our Sangam's representation Suitability Report was called for the Promotion of Assistant Executive Engineer / Mechanical among 100 Assistant Engineers and 35 Junior Engineer / Mechanical I Grade under the crucial date of 05.06.21 vide reference 1 cited above.

After much ado, DPC meeting for the said promotion panel was conducted. But approval of panel has been kept pending for quite some time. It couldn't be processed due to litigations. Our repeated representations to the Personnel Administration wasn't fulfilled.

Hence the matter was brought up to the respected Chairman cum Managing Director during our discussion on 08.08.23. Respected Chairman cum Managing Director had instructed the Chief Engineer / Personnel to revise the Seniority list, thereby comply the Court orders and to expedite the promotion process.

Since then, Personnel Administration has been carrying out the exercise of seniority revision for more than 6 months. Yet the matter hasn't taken a full shape and the process is still continuing keeping the Assistant Executive Engineer / Mechanical aspirants in anguish.

The individuals in the list are totally aggrieved as they are waiting for their legitimate promotions for quite long. Swift promotions to their counter parts in Electrical discipline adds to their woes.

The matter was yet again brought up to the respected Chairman cum Managing Director during our discussion earlier this month on 01.02.24. Respected Chairman cum Managing Director had then assured us of an early orders which is still pending.

At this juncture our Sangam suggests that, the exercise of Seniority Revision may be restricted to this batch alone initially, Panel may be processed and Promotions may be issued as early as possible. Seniority Revision for the rest others may be carried out leisurely later.

We request the respected Chairman cum Managing Director to consider our suggestion. Hence instruct the Chief Engineer / Personnel suitably so as to complete the promotion process early and issue Assistant Executive Engineer / Mechanical Promotions, thereby enlighten the lives of the individuals who are starved of promotions and thus render justice please.
