PROCEEDINGS:

The Board of TANGEDCO has accorded approval vide Proceedings first read above for formation of 2 new O&M Divisions at Pallavaram and Sholinganallur by trifurcating the existing Tambaram Division in Chennai Electricity Distribution Circle/South-II.

- 2) Subsequently, the Superintending Engineer/ Chennai Electricity Distribution Circle/ South-II has submitted a proposal for redistributing the existing Sections among the newly formed Divisions at Pallavaram and Sholinganallur. The proposal has been examined in detail and approved as follows:-
