- (I) If the individual is involved in D.P/Vigilance Remarks and the work and conduct are not satisfactory, the transfer order need not be served to the individual and to send the remarks in this regard to this office.
- (II) If the details furnished by the individual in the Request transfer application is found to be false, the transfer order need not be served to the individual and returned the same to this office along with remarks.
- (III) If the individual has not completed one year service period in the present station, the transfer order need not be served.

- (VI) if the any individual transferred based on vigilance complaint and not completed two years in present place, this order need not be served and intimate the fact to this office.
