Sub : Recruitment (Internal) - Class II Service - Filling up of  
Vacancies of AE/Mechanical by Internal Selection -  
Proposals of qualified employees - Called for – Reg.

\*\*\*\*\*

It is proposed to call for application from the qualified employees of TANGEDCO/TANTRANSCO to fill up the vacant post of Assistant Engineer/Mechanical by Internal Selection as per Service Regulations.

2) The eligibility conditions to apply are as follows:-

- i) The employees who are working in Regular Work Establishment and Provincial Cadres and who are drawing the regular time scale of pay.
- ii) The employee who have passed a degree in Mechanical Engineering of the Chennai or Annamalai University or equivalent qualification as referred to in Regulation 94 (Annexure-III)
- iii) The employees should have obtained the requisite qualification in the pattern of 10<sup>th</sup> + H.S.C. / Diploma + U.G. Degree.

- iv) The employees who have passed B.E./B.Tech (Mechanical) (only part time (or) Regular (or) who have passed the validation exam conducted by AICTE during 2018 as per Hon'ble Supreme Court Orders dated 03.11.2017) or equivalent or Section A and B of AMIE Examination as referred to in Regulation 94 Annexure-III.
- v) The employees who have passed B.E./B.Tech degree through IGNOU by VIEP mode and who have got enrolled only till 2011-2012 and covered in the Hon'ble Supreme Court Orders dated 18.09.2020 are only eligible for applying.
- vi) The equivalency of qualification issued by the Government of Tamil Nadu to the one notified at para 2 (ii) must be submitted by the applicant to enable his/her candidature while submitting application and the said equivalence should have been issued by the Government prior to the date of call letter.
- vii) As per Regulation 95(b) of TNEB Service Regulations the employees who are approved probationer or probationer are eligible to apply.
- viii) The employees who have the requisite qualification and also eligibility prior to 07.06.2022 as per (Per.) FB TANGEDCO Proceedings No.5 dated 07.07.2022 are only eligible to apply for this Notification.
- ix) The employee with adequate knowledge in Tamil as stipulated in (Per.) FB TANGEDCO Proceedings No.42 dated 28<sup>th</sup> November 2019 are only eligible to apply.
- x) The employees who have passed B.E./B.Tech degree through **Distance Education** from any Universities (other than those who got qualified in the validation exam conducted by AICTE during 2018 as per Hon'ble Supreme Court Orders) **are not eligible** for Internal Selection.
- xi) The employees who are involved in D.P/ undergoing punishment on the date of notification are not eligible.

- xii) The Bachelor of Engineering graduates directly recruited as JA/Admin and Typist based on the notifications issued as per Per. (FB) TANGEDCO Proceedings No.10 dated 10.12.2015 are not eligible for internal selection to the post of Assistant Engineer/Mechanical as ordered in (Per.) (CMD) TANGEDCO Proceedings No.47, dated 19.02.2018.
- xiii) Part Time Conservancy worker, Watch & Ward and those who are not in regular time scale of pay are not eligible.
- xiv) The Gangman appointed as per Notification No.01/2019, dated 07.03.2019 are not eligible to apply based on Per. FB TANGEDCO Proceedings No.10 dated 06.03.2019.

3) The selection will be made on merit (length of service in TNEB/TANGEDCO/TANTRANSCO after acquiring degree in regular time scale of pay) and according to the rule of reservation ordered as per TNEB Service Regulation.

4) I request you to give wide publicity by displaying a copy of this communication in the Notice Board in the respective offices and issue circulars to the offices under your control instructing all the eligible willing employees to apply via online in the TANGEDCO intranet URL <http://192.168.150.75/openbd/ISMAE> between 31.01.2024 (11.00 A.M.) to 23.02.2024 (05:00 P.M) and the web portal will get closed automatically on 23.02.2024 at 5.00 P.M.

5) The eligible employees who are willing to apply for the post of AE/Mechanical may be informed to login securely and keep the user id and password received in their email id confidentially. Further, they may also be informed to verify all the details entered while filling application form before submitting it as the application once submitted could not be edited.

6) The eligible willing employees who have applied for internal selection may be instructed to submit the print out of the application downloaded from the website along with the copies of T.C. and documents uploaded by them to their office on or before 04.03.2024, failing which their online application will be automatically cancelled and will not be considered for internal selection to the post of Assistant Engineer/Mechanical.

7) I request you to consolidate the above applications received from the employees and verify the proposal sent by the employee along with the S.R. Book/ Certificates and consolidate the same and send a detailed report with all enclosures along with the copy of genuineness of the qualification if already obtained or send



the report with a remark that genuineness has been called for from the concerned authority. Further, the competent authority may then obtain the genuineness certificate from the concerned department and forward a copy of the same to this office at the very earliest. The competent authority is requested to send the consolidated report along with their certification after verifying the application as stated in the **Annexure**.

8) If any proposals other than those stated in at para 2 above are forwarded to this office without proper verification and certification, it will be viewed seriously and action will be taken on the concerned Staff/ Officer, in this regard.

9) The Selection and appointment to the post of Assistant Engineer/Mechanical is subject to agreeing to the conditions with regard to fixation of pay, etc. as per rules specified. The cases of those, who do not submit their applications to your office on or before the specified date, i.e., 04.03.2024 need not be considered for verification and may be returned to the individual with a speaking order and the same should be informed to this office forthwith.

10) I am also to request you to forward the consolidated proposal furnishing all the required details in complete shape to this office positively on or before 25.03.2024 without fail.

11) If no qualified person is available, a NIL report should be sent promptly.

12) The receipt of this letter should be acknowledged in the first instance.
