It is requested to serve the transfer orders to the individuals, subject to the following conditions and to relieve the individual forthwith


- i If the individual is involved in D.P/ Vigilance Remarks and the work and conduct are not satisfactory the transfer order need not be served to the individual and to send the remarks in this regard to this office.
- ii If the details furnished by the individual in the RTA is found to be false, the transfer order need not be served to the individual and returned the same to this office along with remarks.
- iii If the individual has not completed one year service period in the present station, the transfer order need not be served.
- iv If any of the individual has already considered for transfer to any circle through RTA but not relieved, this transfer order need not be served and intimate the fact to this office.
- v. If any of the individual previously cancelled the transfer order which was considered through RTA and again applied RTA before completion of two years, this transfer order need not be served and intimate fact to this office.
