## **PROCEEDINGS:-**

In the Government Order eighteen read above, orders were issued bifurcating the Tamil Nadu Generation and Distribution Corporation Limited into separate generation and distribution companies, viz., Tamil Nadu Power Generation Corporation Ltd. (TNPGCL) and Tamil Nadu Power Distribution Corporation Ltd. (TNPDCL).

- 2. In the Government Order nineteen read above, orders were issued forming the Tamil Nadu Electricity Restructuring and Transfer Scheme, 2024 which includes the terms and conditions for transfer of personnel of TANGEDCO to TNPGCL and TNGECL. All the Hydro Generating Circles Stations, Wind Energy Generating Stations and the new power projects at Kundah and Kollimalai have brought under the said TNGECL.
- 3. The Chairman cum Managing Director/TANGEDCO has approved the proposal for formation of Accounts Branch for TNPGCL by redeploying the incumbents from various offices of TANGEDCO to Tamil Nadu Power Generation Corporation Limited (TNPGCL).
