Sub: Recruitment – Class III Service - Filling up of Vacancies of Junior Engineer/Electrical II Grade – Appointment by Transfer Method against reserved vacancies for the employees in RWE categories (Non-Diploma Holders) – Applications - Called for – Reg.

Ref: This office Letter No.050482/ G.20/ G.201/ 2023-1, Dt:15.02.2024.

It is proposed to call for application from the qualified RWE employees for appointment to the post of Junior Engineer/Electrical II Grade to be filled up by RWE employees (Non-Diploma Holders) as per provisions in Service Regulation and as (Per) B.P.(FB) No.17, (Sectt. Br.) dated 05.07.2003. The employees working as Line Inspector or on Equivalent Post or on Higher Posts in the RWE cadre, who possess a minimum educational qualification of "a completed SSLC" and who possess not less than 6 years of practical experience in Electrical side in the TNEB/TANGEDCO/ TANTRANSCO and who has adequate knowledge in Tamil (i.e. Pass on Tamil Language in SSLC or Pass on Tamil Language in SSLC written by Private Examination or Pass on Tamil Language Test conducted by the Department) are only eligible to be considered for appointment as Junior Engineer/ Electrical II Grade.

2) The Superintending Engineers and other Competent Authorities are informed that applications were called for from qualified employees previously vide letter No. 050482/G.20/G.201/ 2023-1, dated 15.02.2024 with the following cut-off date.

3) The Concerned Superintending Engineers and other Competent Authorities are requested to send the Annexure –III alone (Enclosed to this letter) to update details of **Disciplinary Proceedings, Post changes, Promotions, Retirements, Relinquishment and Willingness** of the employees who have already applied for previous call for (15.02.2024) (**need not obtain proposals from this employees**).

4) The Concerned Superintending Engineers and other Competent Authorities are also requested to furnish the Disciplinary Proceedings of the applicant as on **04.07.2024** for the earlier applicants who applied for the call for dated 15.02.2024 and also forward the above details on or before 07.08.2024. If an employee who applied in the previous call for (i.e.15.02.2024) has been transferred, **the details of joining in the new circle should be furnished without fail.**

5) The Concerned Superintending Engineers and other Competent Authorities are requested to obtain applications from fresh willing employees within the prescribed cut of date mentioned below and requested to give wide propaganda by calling applications from eligible employees **who did not apply at the time of earlier call for (i.e.15.02.2024) (proposals from new eligible RWE employees along with annexure –II to be obtained and to be forwarded in**

complete shape with annexure –I). The Superintending Engineers and other Competent Authorities are informed that the cut of date has been enhanced only to Scheduled Tribe (ST) Community for want of applications.

6) The Concerned Superintending Engineers and other Competent Authorities are requested to furnish **the correct date of first appointment and also correct date of Joining as Line Inspector or on Equivalent Cadre** of the RWE employees. The experience in Electrical side is a must and only those who are having practical experience of more than 6 years in Electrical field alone **should be recommended** for selection.

7) The Concerned Superintending Engineers and other Competent Authorities are requested that, if any employee requested for alteration of the Community, who have applied for the post of Junior Engineer/Electrical II Grade at present need not be entertained as per B.P.Ms.No.211, (Sectt. Br.), Dated 30.04.1982.

8) The Concerned Superintending Engineers and other Competent Authorities are requested to obtain the applications from the employees who are applying freshly along with attested copies of certificates towards the evidence of their Date of Birth, Community Certificate, SSLC Qualification (SSLC Marks Sheet). The genuineness certificate should have been obtained for the educational qualification

as stipulated in Memo.No.68638/A18/A18/2019-1 (BOBS) dated 04.02.2020 since the declaration of probation for the selectees has to be declared as stated there in. The bio data of employees furnished in their applications may be thoroughly verified with reference to Service Book and a statement furnishing the names of employees applied for the post of Junior Engineer/Electrical II Grade may be prepared as Annexure-I (Specimen Form Enclosed) and the statement may be sent along with the certificates submitted by the employees.

9) In case, Disciplinary Proceedings are pending against any of the employee, the nature of charges on which D.P. has been initiated, the stage at which the D.P. is pending may be indicated and whether the employee is undergoing any punishment, the nature of proved charges, kind of punishment imposed and the date of commencement and the probable date of completion of punishment may also be furnished.

10) The selection will be made on merit according to the Rule of Reservation ordered as per G.O.Ms.No.65, P&AR (K) Department dated 27.05.2009.


11) Further, in order to avoid inordinate delay and to expedite the process the Superintending Engineers are requested to obtain the proposals from eligible employees by giving wide publicity in the field and displaying the call for in the Notice Board and obtain applications from the eligible employees on or before **29.07.2024**. **Further the Superintending Engineer's are informed that, any application received beyond the stipulated period need not be taken into consideration and the same may be returned to the individual with proper reasoning and the said action has to be intimated to this office without fail.** Further the Superintending Engineer's may consolidate the report and send the entire proposals etc., to this office on or before **07.08.2024**. Any applications received beyond that date from the Superintending Engineer's concerned will not be considered for examination and the erring Officials/Staff will be held responsible for the delay and suitable actions deemed fit will be taken in this regard.

12) The Concerned Superintending Engineers and other Competent Authorities are requested to furnish the applications strictly as per the revised cut-off date tabulated above (Table-II) from the eligible RWE employees (Line Inspector or on equivalent category, Foreman, Spl. Gr. Foreman) along with their DP Particulars and other necessary records (Annexure-I & Annexure-II) and to forward the consolidated proposal furnishing all the required details in complete shape so as to reach this office positively before **07.08.2024** without fail.

13) The Concerned Superintending Engineers and other Competent Authorities are requested to furnish the **Disciplinary Proceedings, Post changes, Promotions, Retirements, Relinquishment and Willingness** of the employees who have already applied for the previous call for (15.02.2024) along with Annexure-III alone to reach this office positively before **07.08.2024** without fail. If the employee's DP particulars are not furnished within the last date for receipt of application, their candidature will not be considered for this selection.

14) If no qualified person is available, a NIL report should be sent on or before **07.08.2024**. I am to request you to acknowledge the receipt of this letter.
