### **PROCEEDINGS:-**

In the reference second read above, orders were issued for restructuring of Tamil Nadu Generation and Distribution Corporation (TANGEDCO) into separate Generation and Distribution Companies, a new company named Tamil Nadu Green Energy Corporation Limited (TNGECL) has been formed under the Company Act 2013 by integrating Renewable Energy (RE) wing of TANGEDCO and merger of Tamil Nadu Energy Development Agency (TEDA) with the new Green Energy Company.

- 2. The Director (Generation)/TANGEDCO has proposed for re-deployment of the post of Chief Engineer/IC, R&D, Chennai as Director/Technical, Tamil Nadu Green Energy Corporation Limited (TNGECL) and also attaching the GM/HRD wing under the control of Chief Engineer/Personnel, Administrative Branch and Superintending Engineer/R&D and Superintending Engineer/DSM under the control of Chief Engineer/Commercial/Chennai.
- 3. The above proposal has been examined in detail and it has been decided to accept the same. Accordingly, it is hereby ordered that the post of Chief Engineer/IC, R&D, Chennai last continued in the Memo. first read above be re-deployed as Director/Technical, Tamil Nadu Green Energy Corporation Limited (TNGECL).

- 4. Consequent to the orders issued above, the GM/HRD wing hitherto under the control of Chief Engineer/IC, R&D, Chennai be attached to the Chief Engineer/Personnel, Administrative Branch, Chennai and the Superintending Engineer/R&D and the Superintending Engineer/DSM hitherto under the control of the Chief Engineer/IC, R&D, Chennai be attached to the Chief Engineer/Commercial, Chennai.
- 5. The incumbent of the post ordered in para-3 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.
