PROCEEDINGS:-

In the proceedings read above, the panel for the post of Executive Engineer (Electrical) consisting of 58 candidates for the year 2023-2024 has been issued. Out of the 58 candidates, the candidates mentioned in the panel upto Sl.No.50 (i.e. upto Thiru M.Syed Abdulla) have been promoted and posted as Executive Engineer (Electrical) vide (Per.) The Chief Engineers/Superintending Engineers concerned are directed to relieve the officials under orders of promotion and postings immediately by making local arrangements without waiting for substitutes and instruct them to join at the new posts immediately. Otherwise necessary Disciplinary action will be taken against the concerned Officials. A report shall be sent to the Secretary, Tamil Nadu Generation and Distribution Corporation Limited regarding the date of relieving and date of joining of the officers. The Officers are requested to return the option form duly filled in, within one month from the date of assumption of charge. If the option form is not received within the said period of one month, their pay in the higher post will be fixed as specified in para-3 of Board's Memo.No.75406/P1/90-1, dated 19.03.1991.
