## **PROCEEDINGS**:

Based on the orders issued by the Government in Government Order first read above, orders were issued allowing the Pensioners/Family Pensioners of TANGEDCO to submit their Life Certificate at any time during the months of "July, August and September" every year for annual mustering instead of "April, May and June" to the concerned Pension Disbursing Officers — vide Proceedings second read above. It has also been ordered therein that if any pensioner/family pensioner fails to do so, the Pension Disbursing Authority shall call for the personal appearance in October and the pension/family pension will be stopped from November onwards for those pensioners/family pensioners who neither appear directly for mustering nor furnish life certificates. Accordingly, the pensioners of TANGEDCO submit their Life Certificates through the Indian Overseas Bank.

2. The Government in G.O. third read above have issued orders simplifying the mustering process, by including various options at the convenience of the Tamil Nadu State Government pensioners for mustering and producing Life Certificates. Among others, it has been ordered therein to include the services of the India Post Payments Bank (IPPB), as one of the facilitators to do mustering of the State Government Pensioners through Jeevan Pramaan Portal upon receipt of Rs.70/per Digital Life Certificate for rendering the services, in addition to the existing

method of mustering. After careful examination, it has been decided to adopt the said Government Order in TANGEDCO. As a first step, the TANGEDCO has been On-Boarded in Jeevan Pramaan Portal for submission of Digital Life Certificates by the pensioners of TANGEDCO - vide E-mail fourth read above. Subsequently, the concurrence from India Post Payments Bank (IPPB) for extending the same service to the pensioners of TANGEDCO, as is being provided to the Government Pensioners, has been obtained – vide E-mail fifth read above.

- 3. Accordingly, it is hereby ordered that the Pensioners/Family Pensioners/Ex-gratia Beneficiaries of TANGEDCO, be allowed to choose any one of the following facilities at their convenience for submission of their Life Certificates in addition to the existing procedure of submitting Life Certificates through Indian Overseas Bank:-
  - 1) Submission of Digital Life Certificate (DLC) through Jeevan Pramaan Portal by using the services of any one of the following entities as per the option of the pensioners.
    - a) India Post Payments Bank (IPPB) with Door Step Service (on making a payment of Rs.70/- per DLC).
    - b) E-Seva centres/Common Service Centres.
    - c) Pensioners' Associations having Biometric device connected with Jeevan Pramaan Portal.
  - 2) Submission of Life Certificate through Post.
  - 3) Direct Mustering (Physical Appearance).
- 4. The Chief Engineers, Superintending Engineers and all other Officers are directed to display the copies of these Proceedings in the Notice Board and also to circulate the same to the pensioners during the Pensioners' Grievance Redressal Meetings to create awareness on Door Step Services on Digital Life Certificate by the India Post Payments Bank (IPPB). Further, the Chief Internal Audit Officer/Audit Branch is directed to insist the IPPBs to advertise and reach the Pensioners/Family Pensioners through the Post Offices throughout the State, thereby avoiding hardship to the aged Pensioners/Family Pensioners of coming to the O/o. Pension Disbursing Authorities in person for mustering.
  - 5. The receipt of these Proceedings shall be acknowledged.
