In the proceedings read above the panel for the post of Assistant Executive Engineer/Civil consisting of 9 (1CHD, 6AEs & 2JEs I Gr.) officials has been approved.

2. Under Regulation 92 of Tamil Nadu Electricity Board Service Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010, in Division III, Category-1, Class-II, the promotion and allotment orders is hereby issued to the officials mentioned in the Annexure.

3. The Chief Engineers concerned are requested to issue necessary appointment-cum-posting orders to the official, on promotion as Assistant Executive Engineer (Civil), as per powers delegated in B.P.Ms.No.61 (FB) (Sectt. Branch) dated 01.08.1988, under Regulation 106 of Tamil Nadu Electricity Board Service Regulations, to the circle as allotted under intimation to this office.

4. The Chief Engineers concerned are also requested to incorporate the following clause in the appointment-cum-posting orders to the above promotees :-

- i) The promotees concerned should join duty at the place posted within 2 weeks from the date of issue of this order and no modification of postings will be entertained.
- ii) If he/she fails to assume charges within 2 weeks of relief from the present station, promotion orders will be cancelled.
- iii) The above order is subject to the outcome of the Writ Petitions filed if any pending in the Hon'ble High Court.

5. The Superintending Engineers concerned are directed to relieve the promotees within 15 days from the date of receipt of order, by making local arrangements without waiting for substitute and instruct them to join at the new post immediately, failing which the Officers concerned will be held responsible.

6. The Promotees who do not adhere to the time frame indicated for joining will be proceeded under Rule 8(a) of D&A Regulation as per Memo. No.100855/515/G42/G421/2002-1 dated 30.8.2002.

7. The Superintending Engineers concerned are also directed to serve the promotion order to the above officials only if they are free from disciplinary proceeding/charges framed/punishment awarded/vigilance remarks, otherwise the same may be returned to this office.
