Ref : 1. This office Letter No.031242/G.1/G.1(2)/2021-6, dated 06.04.2022.

## 2. (Per.) CMD TANGEDCO Proceedings No.27 (Administrative Branch), dated 14.03.2024.

In the proceedings read above the panel for the post of Assistant Executive Engineer/Mechanical consisting of 33 (25 A.Es. & 8 J.Es./I Gr.) officials has been approved.

2. Under Regulation 92 of Tamil Nadu Electricity Board Service Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010, in Division IV, Category-1, Class-II, the promotion and allotment orders is hereby issued to the officials mentioned in the Annexure.

4. The Chief Engineers/Superintending Engineers concerned are requested to obtain undertaking (Undertaking Enclosed) signed by the promotees before issuing promotion orders.

5. The Chief Engineers concerned are also requested to incorporate the following clause in the appointment-cum-posting orders to the above promotees :-

- i) The promotees concerned should join duty at the place posted within 2 weeks from the date of issue of this order and no modification of postings will be entertained.
- ii) If he/she fails to assume charges within 2 weeks of relief from the present station, promotion orders will be cancelled.
- iii) The above order is subject to the outcome of the Writ Petitions filed if any pending in the Hon'ble High Court.

The Superintending Engineers concerned are directed to relieve the promotees within 15 days from the date of receipt of order, by making local arrangements without waiting for substitute and instruct them to join at the new post immediately, failing which the Officers concerned will be held responsible.

7. The Promotees who do not adhere to the time frame indicated for joining will be proceeded under Rule 8(a) of D&A Regulation as per Memo. No.100855/515/G42/G421/2002-1 dated 30.8.2002.

8. The Superintending Engineers concerned are also directed to serve the promotion order to the above officials only if they are free from disciplinary proceeding/charges framed/punishment awarded/vigilance remarks, otherwise the same may be returned to this office.
