It is informed that under Regulation 98 (2) (b) of the Tamil Nadu Electricity Board Service Regulations read with Tamil Nadu Electricity (Re-organization and Reforms) Transfer Scheme 2010 that any person who wishes to appeal against non-inclusion of name in the approved list, should do so within a period of two months from the date of communication of the approved list. If no appeal is received within the said period, the approved list communicated shall be deemed to be final.
