Item No.1.4: Sanctioning service connection to Domestic/ Commercial 3 phase services works (Mere SC).

- 2. It was also ordered that the above revised delegation of powers effected for a period of six months from the date of issue of proceedings.
- 3. The TANGEDCO Board in its meeting held on 13.03.2024 has approved to continue the delegation of powers to Officers of TANGEDCO revised vide (Per) FB TANGEDCO Proceedings No.23 SB dated 09.08.2023 till 30.06.2024 and shall be reviewed subsequently.
- 4. Accordingly, it is hereby ordered that the powers delegated to the Officers of TANGEDCO in Item No.1.2 and Item No.1.4 mentioned in para-1 above be continued till 30.06.2024.
- 5. Except the above provisions, all other Items in the (Per) FB TANGEDCO Proceedings No.71 Technical Branch dated 29.06.2011, (Per) FB TANGEDCO Proceedings No.1 SB dated 06.01.2021 and (Per) FB TANGEDCO Proceedings No.9 SB dated 02.03.2023 shall remain unaltered.
