## PROCEEDINGS:

Tamil Nadu Generation & Distribution Corporation Ltd. hereby accords administrative approval subject to that "the local bodies should be charged the lesser of actual cost of effecting the street lights or the escalated cost as per the Government order of Rural Development Department issued during 2013" for the proposal mentioned below to send to the Government of Tamil Nadu:

"To adopt the actual cost of estimate generated through ERP for provision of street lights to all the Local Bodies viz., Rural Local Bodies(Village Panchayats) and Urban Local Bodies (Corporations, Municipalities & Town Panchayats) based on the actual cost of inventory as per the ERP and to sanction the estimates as being done for extension of work (E.O.S) estimate, DCW estimates etc., to other consumers, instead of existing method of adopting flat rates".

The method to adopt the lesser cost for providing street lights to Local bodies is as below:

- i. calculate the actual cost of effecting the street lights as on date as per ERP.
- ii. calculate the 5% escalation cost for Rs.22150/- (which was approved by the Board during Oct'2016) from 2017-18 every year as per G.O. furnished during 2013 in which approval was given for adopting escalation 5% concept.
- iii. the lesser of the above two costs is to be adopted for providing street lights to Local bodies.
