**PROCEEDINGS:**

In the Proceedings first read above, orders were issued allowing 50% Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation (now Tamil Nadu Power Distribution Corporation Limited) with effect from 01.01.2024.

2. In the Government Order second read above, orders have been issued revising the rate of Dearness Allowance from **50% to 53% (3% increase)** payable to the Pensioners/Family Pensioners of the State Government with effect from **1<sup>st</sup> July, 2024**.

3. It has been decided to extend the same benefit to the Pensioners/Family Pensioners of TNPDCCL. Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of TNPDCCL, be paid Dearness Allowance with effect from **1<sup>st</sup> July, 2024** at the following rates:-

<b>Date from which payable</b>	<b>Revised rate of Dearness Allowance (per month)</b>
<b>1<sup>st</sup> July, 2024</b>	<b>53% of Basic Pension/Family Pension.</b>

4. The revised rate of Dearness Allowance from **50% to 53%**, ordered in para-3 above, for the period from **01.07.2024 to 31.10.2024** shall be paid to the Pensioners/Family Pensioners along with the Pension/Family Pension for the month of **October 2024**.

5. The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

6. In the case of divisible Family Pension, the Dearness Allowance shall also be paid proportionately.
