#### ORDER:

2) In the Government Order second read above, the Government have issued orders for formation of Tamil Nadu Green Energy Corporation Limited (TNGECL) under the Companies Act, 2013 by integrating Renewable Energy Wing of TANGEDCO and merge of Tamil Nadu Energy Development Agency (TEDA) with the new company.

3) In the letter third read above, the Chairman and Managing Director, Tamil Nadu Power Distribution Corporation Limited has sent proposal for appointment to the post of Directors in Tamil Nadu Power Distribution Corporation Limited, Tamil Nadu Power Generation Corporation Limited, Tamil Nadu Green Energy Corporation Limited and Tamil Nadu Transmission Corporation Limited.

4) The Government, after careful examination, have decided to accept the proposal of the Chairman and Managing Director, Tamil Nadu Power Distribution Corporation Limited in paragraph 3 above and accordingly appoint the following officials as Directors in Tamil Nadu Power Distribution Corporation Limited (TNPDCL), Tamil Nadu Power Generation Corporation Limited (TNPGCL), Tamil Nadu Green Energy Corporation Limited (TNGECL) and Tamil Nadu
